Candidates have been surveyed and rated by Illinois Right To Life Action (IRLA) with respect to pro-life issues (Abortion, Euthanasia, Embryonic Stem Cell research and related issues). This was done through **websites, surveys, public statements, and/or voting records**. The ratings are to the left of the listing and represent the following:

- 1 = Fully Pro-Life
- 2 = Not in full support of all Pro-Life issues
- * = An asterisk indicates incumbent.
- + = A plus indicates an incumbent who voted NO on the state budget that included state funding of abortions (HB 40)
- 3 = Will not support most Pro-life issues
- 4 = Totally opposed to Pro-Life issues
- # = Rape and Incest Exception
- U = Unknown (Did not complete a survey, or a current survey, or we do not have enough information to enable IRLA to rate properly.)

X = Does not have a Pro-Life position, but we do not have enough information to enable IRLA to give a number rating.
